

PAGE 3-SENATE BILL 23-007

Recognized Adult Education Providers

"Adult education provider" means one of the following entities that the department recognizes as providing appropriate and effective adult education and literacy programs:

- a secondary or postsecondary, public or private, nonprofit educational entity:
 - school district, charter school, board of cooperative services, state institution of higher education, local district college, and area technical college
- a community-based nonprofit agency or organization
- an Indian tribe or nation
- a library
- a literacy council or other literacy institute
- a business or business association that provides adult education and literacy programs either on site or off site;
- a volunteer literacy organization
- <u>a local workforce board</u>
- a One Stop Shop Partner under the Colorado Career Advancement Act
- Consortia of entities described above





Education Attainment Partners

"Education attainment partnership" means a collaboration that assists adults in attaining basic literacy, digital literacy and numeracy skills that lead to additional skill acquisition and *may lead to* postsecondary credentials and employment.





Page 3-SENATE BILL 23-007

Eligible Adult Education Providers for AELA's Education Attainment Partners

For AELA's Educational Attainment Partners, the "adult education provider" must include at least one:

- Community-Based Nonprofit Agency or Organization
- Business or Business Association
- Indian tribe or Nation
- Volunteer Literacy Organization
- Library
- Literacy Council or Other Literacy Institute
- Local Workforce Board
- One-Stop Partner

Local Adult Basic Education Provider



Eligible Adult Education Providers for AELA's Education Attainment Partners

For AELA's <u>Educational Attainment Partners</u>, the "other education provider" must include at least one:

- Elementary School
- Secondary School
- Charter School
- School District
- Board of Cooperative Services
- State Institution of Higher Education
- Local District College
- Area Technical College

Other Education Provider (K-12, HED, CTE, etc)






Workforce Development Partners



"Workforce development partnership" means a collaboration that assists adults in attaining basic literacy, digital literacy, and numeracy skills *leading to* additional skill acquisition, postsecondary credentials, and employment.

At a minimum, a workforce development partnership must include at least one adult education provider AND at least one workforce development provider.

For this partnership, there could be an optional postsecondary education or training provider.



Page 4 -SENATE BILL 23-007

Eligible Workforce Development Providers for AELA's Workforce Development Partners

For AELA's <u>Workforce Development Partners</u>, the workforce provider must be from:

- A program that is supported by the <u>Colorado Workforce Development Council</u> (CWDC):
 - A public or private sector employer, employer organization, or trade association
 - An apprenticeship sponsor
 - A community-based organization
 - A Colorado workforce center
 - A <u>sector partnership</u> recognized by the CWDC under the "<u>Colorado Career Advancement Act</u>"

Workforce Development Provider



(C.R.S. §22-10-103(11)(c))

Eligible Post-secondary or Training Providers for Workforce Development Partners (not required - optional)

For the purpose of the Workforce Development Partnership, applicants may include at least one post-secondary or training provider:

- A state institution of higher education, local district college, or area technical college
- An apprenticeship program
- An entity that provides accelerated education and skills training certificate programs created pursuant to <u>career pathways</u> or <u>Title 24 of Colorado Revised Statutes</u>
- An entity that operates programs through the <u>manufacturing career pathway</u>, such as <u>Skill Advance Colorado</u>, established by the State Board for Community Colleges and Occupational Education
- A community-based workforce development program that is operated through the <u>Colorado customized training program</u>









Roughly \$3 million is available for the 2025-2026 fiscal year, with funding contingent on approval of appropriations from the State Legislature. Grants will be awarded for a fouryear term beginning July 1, 2025, and ending June 30, 2029. Additional grant funding for subsequent years will also be contingent upon annual appropriations by the State Legislature, and grantees meeting all grant, fiscal, and reporting requirements. Funds must be expended by June 30 annually.

Funding in subsequent years for grantees is contingent upon funding appropriations and grantees meeting all grant, fiscal and reporting requirements.
