



As with other Colorado state content assessments, Multilingual learners are included in the CO PSAT and the CO SAT administration unless the student is excused by their parent/guardian through the standard procedure outlined in the district’s state assessment parental excuse policy (C.R.S. §22-7-1013 (8)). Students who are Non-English Proficient (NEP) and first year in a U.S. school are exempt from the Evidence-Based Reading and Writing assessment. However, these students still count as participants for state and federal accountability reporting. Parents/guardians of NEP Newcomers may choose to have their child participate in the Evidence-Based Reading and Writing assessment; in those instances, results are reported for state and federal accountability. There are several assessment supports available for ML students.

| Additional option for MLs with an IEP or 504  | Information About Option   |
| Student tests with other College Board approved accommodations if the student has a disability that qualifies him/her for testing with accommodations.  | <ul style="list-style-type: none"> <li>The student may choose to use: an <a href="#">approved word-to-word bilingual dictionary</a> and/or <a href="#">translated test directions</a> (does not require pre-approval).</li> <li>Test accommodations for MLs with an IEP or 504 plan must be submitted into College Board’s SSD Online accommodations system <b>before February 18, 2025</b>.</li> <li>Students with disabilities testing with approved College Board test accommodations will receive scholarship and/or college-reportable scores.</li> </ul> |
| Additional option for MLs who are NEP and who have been in the US for less than one year  | Information About Option   |
| Student tests in a state-allowed separate accommodations room for students who are not going to attempt the Reading and Writing sections of the assessment. (First year in US NEP students are counted as participants for state and federal accountability, any other students are considered non-participants). For 2024-2025, the cut-off date is <b>April 15 2024</b> . | <ul style="list-style-type: none"> <li>The student will NOT receive scholarship and/or college-reportable scores.</li> <li>For any school considering this option, the DAC must contact Melissa Carpenter at <a href="mailto:Carpenter_M@cde.state.co.us">Carpenter_M@cde.state.co.us</a> (reminder, do not send student personally identifiable information via email).</li> </ul>  |
