

Colorado Board of Education Members 1876 – present

The Colorado State Board of Education was established in the 1876 Colorado State Constitution and comprised of the Superintendent of Public Instruction, the Secretary of State and the Attorney General.

In 1948, the Colorado State Constitution was amended to authorize an elected State Board of Education to provide general supervision of public schools, with powers and duties described throughout Title 22 of the Colorado Revised Statutes. The first Board was elected in November 1950, and began its work in January, 1951.
